#### Tuesday August 19, 2014 HVCA Long Range Plan Meeting

Dennis Robinson, Ricki Shepherd, Karla Jarvis, Tracy Shisler, & Kate Sutherland in attendance

- Ocean front Parcel from HI Ocean Center discussed
- We will wait for the appraisal from Anne Baum, have a joint meeting with the Trustees once we get that back, and then decide when to have a community meeting to discuss.
- We will also look into properties for sale currently in the village Karla offered to research this.
- Discussed \$800,000 for these parcels, this would be close to the amount we paid for the Eagle Pass property which will be paid off soon. But again, we need to wait for the appraisal and see what we get there.
- Ricki brought some information on the bathhouse they put in up in Salvo so we had some firm numbers to discuss about how much it might cost to build one on the property. We also discussed the yearly cost to us in addition to the payments on the loan to purchase we would need a lifeguard (est. \$40,000/year) and someone to do the maintenance (est. \$30,000/year).
  - A pier is not a realistic plan.

We also discussed priorities for the HVCA – what we feel should be in our long range plans.

- Sidewalks
- I think we all agreed that this should be a priority for the village with parking areas at each end.
  - Look into Pathways \$ from the Tourism Bureau

#### Medical Center

- Report from Dennis about how things are going over there. We all agreed that we need to do a publicity campaign for this to debunk myths and get information out there. It is a place for anyone to go and is not restricted to just Hatteras village residents. Since we cannot put a sign out in front of the Medical Center, Tracy mentioned using the HVFD sign board & the HVCC sign board to get information out there. Karla will look at flyers Dennis already has and get them tweaked for us to give to businesses. We agreed that Jane would be an excellent person to take some to local businesses plus Kate offered to post in all Post Offices on the island. Ricki and Tracy mentioned getting some air time on Radio Hatteras for an "ad" for the center and we can also get information out there via Island Free Press, the Coastland Times, and other local publications.
- We all agreed that this should be something to support as we move forward. Dennis is looking into getting some solid numbers relating to the operation of the Medical Center.
- There is also the question of if we can use funds from the HVCA for a building that is not owned by us Dennis might be looking into this? Or will designate someone to do so.

   Amphitheater in Hatteras village
- Karla said she and Jon have been discussing this for a couple of years and think it is a viable project and would be a good addition to what we have already. Everyone was receptive to the idea and we discussed using the Eagle Pass property? It would not be an extremely expensive undertaking and would be beneficial to the community especially since it would be a one of a kind venue for use by our schools and could be a source of income renting it out for events. We agreed to check the Eagle Pass property to see if it might be possible to put one there, we are able to fill 10% of this according to Ricki, so we will keep that in mind. We also will have this in mind when Karla brings us a listing of what is available in the village (previously mentioned under the HIOC property).
- A new idea was thrown out there by Karla since we have the Offshore Open and the Surf Fishing Tournament why not start an Inshore Tournament? It would be an additional source of income and we could do it we would have to discuss when it could happen. What would be the best time we needed a little influx in the village over the summer? When would be the best time for fishing inshore? Anyhow, it's out there for thought! We all agreed to discuss it further.
- There was also a discussion about the original agreement between the Trustees vs. the Board and also the distinction between the Tax District & the Civic Association Dennis had printed out the county listing for properties we own and we were just not clear on this (who owns what, why, etc.). It was suggested that we get the county attorney to research this for us. We will see if we can find the original agreement and if not, we should be able to contact the Wheeless office to get a copy since they drew it up for us.
- Finally, Ricki brought up the possibility of a tax increase for the village to fund these projects. Once we have a clear plan for our future goals, we need to ask the community if they are willing to see a .25% or .5% increase in local taxes to help fund these goals. It would help to have a graph, or some sort of visualization that would make it clear to people that this basically means (for .5%) \$50 on \$100,000 of your tax value.

The oceanside value being 850,000.00\$, Soundside lot #10 85,000.00, 58682 Highway 12 85,000. Dennis Robinson commented that he does believe that there is a benefit to the community holding these properties and there is a price point that would make them beneficial but not at the cost of one million dollars, the same feeling was echoed by vice chairman Bill Ballance. Mr. Scott reported that people he has spoken personally, are against community monies being used and was fearful of a property tax increase if the properties were purchased. Mr. Dan Oden commented that the Coast Guard Beach at the west end of the village does offer beach access, but lacks a bathhouse and questioned wether the village needed to go into debt. Mr. Kelmer stated he would like to see any money spent used to improve properties the community already has, and the idea of getting sidewalks in the village is far more appealing to him.

Long Range Plan Meeting: The long range plan meeting board met, they came to a consensus that sidewalks should be a priority, and discussed a possible ampitheatre at the Eagle Pass Property, and an inshore fishing tournament. Mr. Scott made a motion to add the minutes to the Civic Association minutes, and was seconded by Mrs. Shisler. vote was unanimous.

## Special Joint Meeting of Hatteras Village Civic Association and Tax Trustees regarding Purchase of Beach Property from Hatteras Ocean Center

Members in attendance:

Tax Trustees, Rom Whitaker, Geraldine Farrow, Ricki Shepherd, Ernie Foster, Richie Midgette

HVCA Directors, Dennis Robinson, Jane Oden, Bill Ballance, Kate Sutherland, Dan Oden, Jon Kelmer, K.P. Scott, April Webster Financial Specialist, Carol O'Neal

**Discussion on Beach Property**: Ernie Foster opened discussion with a statement announcing ,in his opinion, the Tourism Board wanted to give some grants to Hatteras Island. He felt the community was deserving in the tourism board's eyes of receiving grants ,and private conversations he has had with members of that body in the past, the members of that board have asked, "where are the requests from Hatteras Island?" Mr. Foster seemed to believe with proper grants the community could and should try to purchase the property.

Mr. Scott and Mr. Robinson countered that in both of their opinions the number of 1.2 million quoted by Mr. Eric Kaplan or even 1 million dollars was not feasible by the community without significant sacrifice. Both directors pointed to the purchase of the last property made by combined boards (Eagle Pass Road Property). The property has been unable to be significantly improved because of financial restraints, due to the note on the property. Both directors stated that they believed other future projects would be constrained or untenable because of the commitment.

Mr. Midgette countered the above argument, in his opinion, the deal needed to go forward because the benefit to the community would far outweigh the costs. Mr. Ballance asked Mrs. O'Neal what a reasonable number for the purchase would be. No number was given but she stated 1.2 million at 5% interest for 30 years (a purely hypothetical number based on an educated guess) would be a payment of 6441.56.

Mr Robinson pointed out that only one thousand dollars less a month than the Eagle Pass property and the beach property will take thirty years to pay off. He stated "he did not feel comfortable with that". Mr Midgette than stated "we have to sit down and give the man a number". Mr Ballance noted we did not have a hard number to start and the combined boards needed one.

A motion was made before the Tax Trustees by Rom Whitaker and seconded by Ernie Foster, "a motion to pursue purchase and meet with Mr Eric Kaplan to find firm number that Ocean Center would accept". The motion was passed 4-1, The only nay vote was Ricki Shepherd.

The same motion was made for the Hatteras Village Civic Association Board by Jon Kelmer and seconded by Dan Oden. The motion passed 5-3, the nay votes were Dennis Robinson, April Webster, and K.P. Scott.

Ernie Foster stated before the meeting was adjourned that the project should proceed but not at the expense of other projects.

Mary Helen gave a presentation about sidewalks in Hatteras village. Since funding is no longer available for sidewalk projects, she discussed the possibility of a storm water system that would incorporate sidewalks as a part of that plan and create green spaces with those sidewalks. Hatteras needs to form a committee to move forward with this project. It would be beneficial to have at least one board member on the committee. It is possible to create a special tax district through Dare County specifically for this project. She gave us an example in Duck where their sidewalks were funded in this manner. This was an informative and interesting presentation and we thank Mary Helen for taking the time to meet with us!

#### Tax District:

Carol O'Neal gave us a financial report. She will ask the Tax Trustees to move money from Acquisitions to the Operating Account to fund the ongoing repairs in the Community Building. HVCA financials: still waiting on grant money from the Story Telling Festival, one check was returned from the Surf Fishing Tournament (a registration for two teams)

Community Building Update: The AC units are back in, project is moving ahead, should be done in two to three weeks then they will move on to the library. They are doing a good job.

Review of Minutes: The October 8, 2014 minutes were reviewed and approved. We also reviewed the minutes from the joint meeting on September 25, 2014 and made one change to the wording of the motion made before the Tax Trustees from "a motion to pursue purchase and meet with Mr Eric Kaplan to find firm number that the Ocean Center would accept" to "a motion to meet with Eric to investigate buying the property in order to come up with amount of purchase price and financing options". The motion to approve this change was made by Tracy Shisler, seconded, and passed unanimously.

#### Civic Association Committees:

Story Telling Festival: In 2015 the festival is going to try to focus more on our local storytellers instead of spending a lot on big names in the storytelling community. It will be held the first weekend in May.

HVOO Update: The committee has now met twice since our last meeting. Karla updated and redid the sponsorship packet and it is already making its way to some potential sponsors. It was decided that Dan Oden and Beth Rooks will be co chairs for the event in 2015. The committee decided not to redo the website for this year, perhaps a student volunteer can come up with something to use for 2015 or Kate will update the site we currently have.

Nominating Committee / Annual Meeting: Jane has resigned from the board, so Ryan McClay was nominated by Dan Oden to fill this vacancy. Tracy Shisler seconded this motion and Ryan was approved by all.

Parade/Dance December 13th: Dennis reported that things are moving forward and he brought flyers for distribution. Still are not sure about a dance, some bands have been contacted, but a firm commitment has yet to be received.

Day at the Docks: Will be September 17, 18, and 19th in 2015, Kate needs to let Buddy know so the website can be updated. Also received a quote from Buddy Swain to redo this site and Kate met with Diane Bognich about the grant application for 2015.

Website: Kate will meet with Buddy Swain to see if he wants her to take over updating the website for the HVCA. As previously mentioned, the HVOO site is not going to be updated by Buddy for next year, but Karla will look into having a high school student put one together for us. The new site for DATD should be covered by grant monies for 2015.

Correspondence: Kate reported that things are going well.

Rentals: Kate met with Janice Willis and Rosa Alice Mayo about the rental buildings. The rental contracts/agreements for both buildings are going to be reworked by Kate. She hopes to have them ready and posted by January 2015.

Old/New Business: Jon met with Bob and Christian Dunville about mowing the property (lot) adjacent to the Civic Center once a month. They quoted him \$100 for this work. The members of the Civic Association, led by Jon, will do an initial clean up to prepare the property for monthly maintenance beginning the first of the year. This should be about \$700 per year in additional landscaping expense, Carol reported that it should not be a problem to add this to our expenses. Dan Oden made a motion to budget for the upkeep of the Jackie Faye property (mowing), Tracy Shisler seconded the motion, and it was approved unanimously.

Dan motioned to adjourn the meeting, Tracy seconded, we did so at around 8:30.

## Special Hatteras Village Civic Association Meeting (to further discuss purchase options, regarding Oceanfront Property, offered to Community by Eric Kaplan)

**Members in attendance:** Dan Oden, Karla Jarvis, Kate Sutherland, April Webster, Tracy Shisler, K.P. Scott, Dennis Robinson, and Bill Ballance.

Call to Order and Discussion, Chairperson Dennis Robinson briefed the directors on the current information regarding the purchase of the property,

Eric Kaplan has contacted several banks inquiring about terms regarding a loan in the name of the HVCA. (The terms from two banks are included in the minutes.) Mr. Robinson presented the board with a spreadsheet showing the terms. He then asked for the thoughts of all directors in attendance.(These are their paraphrased thoughts)

Tracy Shisler does not want to place the community in long term debt that would hinder other responsibilities. She believed the price of 1.2 million was far to high. The purchase with the current terms would be "irresponsible".

K.P. Scott stated he did not believe the long term debt at the terms being offered was something the community needed. He further stated that he was concerned about interest rate hikes during the lifetime of the loan. Mr Scott was also fearful of a tax increase for the public when other expenses (insurance, improvements etc.) regarding the property came to bear.

Dan Oden did not think 1.2 million was feasible. He however believes the property would be a positive for the village, but their are two many unknowns. He stated it was hard to go forward without a plan for a 1.2 million dollar property and did not see how the village could commit to such a large purchase on the terms being offered. He did think (Ernie Foster, Tax Trustee, and Dare County Tourism board member) would at the special joint meeting between the two groups the following evening, tell the directors and trustees he felt the HVCA could obtain a grant of \$325,000.00 after the purchase was made. Mr Oden did not believe this was enough to offset the purchase price and make the debt significantly less burdensome for the community.

Karla Jarvis said she was against the purchase because she believed the debt would "be financially irresponsible" She was scared of interest rate hikes and did not think the loans were good for the community.

April Webster also felt the debt would be overwhelming for the community and did not think the purchase was a good plan.

Kate Sutherland said she thought at the end of the last meeting the purchase price was going to be negotiated down and when that did not happen her support waned. She was further bothered by the lack of community involvement. She did not feel comfortable there was not a community meeting and the purchase could possibly move forward without a survey of public opinion.

Dennis Robinson listed his reasons for opposing the purchase, paying \$184,000.00 over appraised value, buying before grant funds are available (part F application due in February, decision in July), No Plan, (cost to develop,cost to maintain or cost to insure are available), At \$875,000.00, at 2.5% interest for 15 years the interest comes to \$175,000.00 at 30 years it is \$369,000.00.He further noted the Community still owes on

the Eagle Pass property and has been waiting to make improvements until the debt is paid off. He continued with his argument that all available property has not been investigated, and there would be minimal financial cushion for future years if the purchase was made. He finally stated he did not want to see all other village projects placed on hold in perpetuity for this one 'opportunity".

Discussion ended with Mr. Robinson

A motion was made by K.P. Scott following the debate "based on the information that we as a board of directors have as of November 17, 2014, we do not believe the purchase of these properties are feasible". The motion was seconded by Tracy Shisler. The vote was unanimous.

The meeting was adjourned at 8:15 p.m.

# November 17, 2014 Special Joint Meeting of Hatteras Civic Association Board of Directors and Tax Trustees for Hatteras Village Special Tax District

Members in attendance: <u>Hatteras Village Civic Association</u>- Dennis Robinson, Kate Sutherland, Jon Kelmer, Karla Jarvis, April Webster, Dan Oden, Tracy Shisler <u>Tax Trustees</u>- Jeraldine Farrow, Ernie Foster, Richie Midgette, Rom Whitaker

Call to Order and Discussion: Richie Midgette announced the Tax Trustees had voted to move forward with the purchase of the oceanfront property. Rom Whitaker and Ernie Foster made known, after the announcement, they did not wish to move forward without the blessing of the HVCA.

Ernie Foster also stated that Outer Banks Tourism Board may be willing to make a grant of 325,000.00\$. Carol O'Neal stated the Eagle Pass road project would be paid off in August.

K.P. Scott asked Mr Midgette about a note in the financing terms requiring the leverage of additional collateral to obtain the loan to purchase the property. Mr Midgette replied that additional collateral would not be necessary but did not elaborate.

Jon Kelmer said he would like to see other projects in the village move forward and Dan Oden referenced the vote the HVCA made the night before, and echoed his views from the previous evening by stating that their are too many unknowns for him and still did not want to move forward without a plan for the expensive property.

Mr Whitaker then quickly countered that if the HVCA board was not interested we (Tax Trustees) need to drop it. Mr Foster then stated best case scenario is 500,000.00 in grants at 5.75% for twenty years is a 4430/month payment for the community and wanted to know if that would make the purchase more palatable for the HVCA Directors. He received no answer.

Tracy Shisler then said the members of the community needed to be notified and certain questions and honesties would need to be addressed. She said the public would need to be notified and the trustees would need to be honest regarding the potential for a tax increase.

Mrs. Farrow the asked how it was possible the HVCA would not move forward with the purchase when the Tax Trustees had always approved everything the HVCA had asked for in the past? She received the answer from Dennis Robinson, "this is just one project and I don't feel comfortable with it"

K.P. Scott then made a motion" The board of the Hatteras Village Civic Association has decided to not pursue negotiations for the General Mitchell and Sandbar property. Tracy Shisler seconded the motion and the Hatteras Village Civic Association voted unanimous. (The Tax Trustees of Hatteras Village made no vote at the meeting) Mr Kelmer made a motion to adjourn and the motion was seconded by Tracy Shisler. Respectfully Submitted Kenneth Scott
